#### Item 8.01 Other Events.

TransAct Technologies Incorporated (the "Company") today announced that it recently discovered a criminal cybersecurity incident impacting its operational and information technology systems. The Company is currently working with a team of forensic experts to fully understand the extent and implications of this incident and to fully restore operations within a safe and remediated environment.

Remediation efforts are in process and being implemented as quickly as possible, and teams are working to maintain the Company's operations and to minimize the impact on its customers and employees. As of the date hereof, the Company has restored certain of its critical operational data and business systems, and continues to work to determine whether this incident will have a material impact on its business, operations or financial results.
